4. FIRST AID MEASURES

A. Eye contact

5. FIREFIGHTING MEASURES

- Move container to safe area from the leak area.

- Prevent runoff and contact with waterways, drains or sewers.

- Large spill: Stay upwind and keep out of low areas. Dike for later disposal.
